A RESOLUTION APPROVING A CONTRACT WITH GLOBE CONSTRUCTION, INC., FOR THE 2018 CONCRETE FLATWORK PROGRAM

WHEREAS, Globe Construction, Inc., has been determined by the Village of Woodridge as the lowest responsible bidder and the Village staff recommends entering into a contract for the Village's 2018 Concrete Flatwork Program pursuant to said bid terms; and,

WHEREAS, the President and Board of Trustees have reviewed the staff's recommendation to accept the proposal from Globe Construction, Inc., and determined that it is in the best interest of the Village to accept said bid terms in the proposal to the Village.

NOW THEREFORE, BE IT RESOLVED, by the President and Board of Trustees of the Village of Villa Park, DuPage County, Illinois, as follows:

Section 1: That the proposal entitled *PROPOSAL FOR THE 2018 CONCRETE FLATWORK PROGRAM* from Globe Construction, Inc., of Addison, Illinois, in an amount not to exceed \$49,977.97/\$74,993.38 (Delete one amount) for the 2018 Concrete Flatwork Program, incorporating the terms and conditions from joint bid number 2018-04, attached hereto and made a part hereof as Exhibit A, be and is hereby approved and the Village Manager is hereby authorized to execute such Proposal.

Section 2: That this resolution shall be in full force and effect from and after its passage and approval according to law.
