

**RESOLUTION NO. 18-67**

**A RESOLUTION AUTHORIZING A CONTRACT WITH SUPERIOR ROAD STRIPING INCORPORATED OF MELROSE PARK, ILLINOIS, FOR THE 2018 PAVEMENT MARKING PROGRAM**

**WHEREAS**, the Village of Villa Park is a municipal corporation duly organized and existing under the laws of the State of Illinois; and,

**WHEREAS**, Section 2-220(b) of the Villa Park Municipal Code permits the procurement from the joint bidding results by a local governmental unit or agency thereof without conforming with the competitive bidding requirements of Chapter 2, Article II, Division 2 of the Villa Park Municipal Code; and,

**WHEREAS**, the Suburban Purchasing Cooperative has on behalf of units of local government bid for the installation of thermoplastic pavement markings on asphalt roadways pursuant to cooperative contract #158; and,

**WHEREAS**, the President and Board of Trustees have determined that it is in the best interests of the citizens of the Village of Villa Park to participate in the Suburban Purchasing Cooperative for the installation of thermoplastic pavement markings on asphalt roadways; and,

**WHEREAS**, the Village's Engineering Division has requested from Superior Road Striping Incorporated a quote for pavement marking on concrete streets that was not included in the Suburban Purchasing Cooperative bid process; and,

**WHEREAS**, Superior Road Striping Incorporated provided a quote for such concrete roadway markings that the Engineering Division is recommending to the Village Board based on that Superior Road Striping Incorporated will already be in the Village marking the asphalt roadways and on the good quoted price for such additional work; and,

**WHEREAS**, the Village Board has reviewed and agrees with the recommendation of the Engineering Division for the accepting of the quote from Superior Road Striping Incorporated and the waiving of the bid for that portion of the work.

**NOW THEREFORE, BE IT RESOLVED** by the President and Board of Trustees of the Village of Villa Park, DuPage County, State of Illinois, as follows:

**Section 1:** That the Village agrees to participate in Suburban Purchasing Cooperative Contract #158 for thermoplastic pavement markings on asphalt roadways and waive the bidding process and accept the additional quote for pavement markings on concrete roadways both contained in the proposal dated September 13, 2018 entitled *PROPOSAL* from Superior Road Striping Incorporated, Melrose Park, Illinois, in an amount not to exceed \$51,489.10, and the Village Manager is hereby authorized to execute the proposal and related contract documents on behalf of the Village of Villa Park.
